Congratulations and thank you for choosing Andi to enhance your wedding experience! Listed below are the details for the special day and options for what we can include. These prices are subject to change. These packages are also priced for indoor ceremonies where a piano (tuned and in working order) is provided. Please see the extras section if a keyboard and generator are required.

### *The Standard Package - \$300.00*

- Thirty minutes prelude music
- Up to three songs for the processional. Most common are for the Parents, Wedding Party, and Bride.
  - Recessional

- Thirty minutes postlude.

## *The Premium Package-\$350.00*

- Everything in the standard package
- Additional two songs for the processional
- Special ceremony music (Unity Candle, Sand, etc.)
- Additional two songs for recessional
- Additional fifteen minutes for prelude and postlude music. Equals forty-five minutes for each.

## *-Extras-*

- Complete Sound System with Technician. This is not a DJ.  
Ask for Prices and Availability.
  - Keyboard-\$150
  - Generator-\$200
  - Additional Songs-\$15 per song
  - Extra rehearsals- \$50 per hour
- Mileage. Anything outside of Jackson County is subject to .50 cents per mile charge. Subject to change.
  - Vocals- \$50-\$100
  - Extension Cords-\$25 per cord

## *-Payment Options-*

We accept Cash, Check, or Credit Card. Please make all checks out to Andrea Wynn – Chatfield. Any returned check will be charged and additional \$30.00.

A deposit of \$100 is required to hold the date. This is non-refundable. A 48 hour notice must be given for any cancellations. This will result in a refund of half the total cost.

Any cancellations given later than 48 hours will be given no refund. All payments must be received before the dress rehearsal.

### *-Other Information-*

Dress Rehearsal- We will be available for up to 90 minutes for the rehearsal. Any time that surpasses this may be charged an additional fee.

Weather- We plan for all weather but there are times that electronics and weather conditions do not mix. We plan to always be prepared but there are some things that we cannot possibly do. If it is an outdoor wedding with no shelter and it is raining, we will not perform. Our gear cannot withstand extreme weather. It is helpful when looking for a venue to also keep the musicians in mind. If there is an alternate location that is protected from the elements, we will gladly make any adjustment needed.

Please make sure that there is a power source that we can use. If not, we need to know with enough time to rent the generator. We will stay only for the parts that we need. We set up, do the ceremony, and leave. If our presence is requested during the reception, we need to know in advance. We need at least a months' notice to prepare for a wedding.
